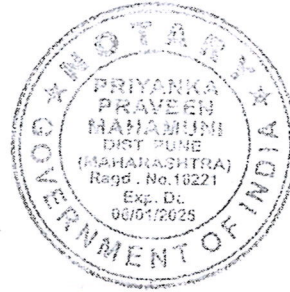

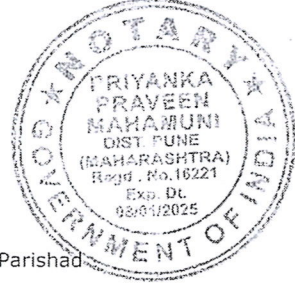

AND WHEREAS, to execute research programmes, policy papers and clinics for various legal faculties, to conduct law related workshops, seminars and study circles etc.

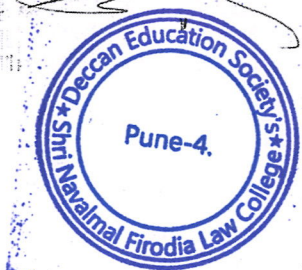

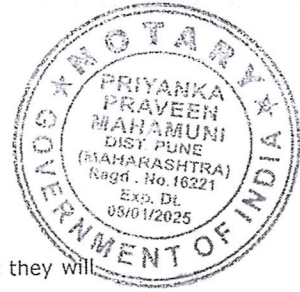
1. The Party of the First Part and Second Part shall coordinate with each other for effective running of legal aid center. (न्याय केंद्र)

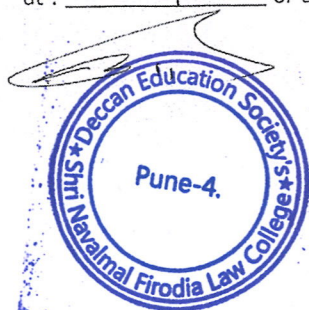

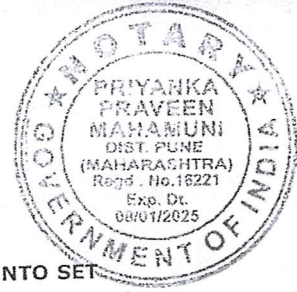
3. Parties of this covenant do here by agree and confirm that they will take collaborative effort in providing legal education, legal literacy and carry on activities in relation there to.

It is the intention of the Party of the First part to get the legal aid and assistance and associate for this socio-Legal cause with Law College, Party of the Second part.

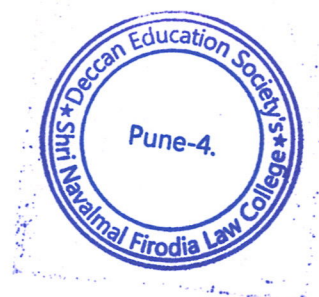

AND WHEREAS, after due discussion between the parties herein, they have decided to enter into and execute in writing this MOU on mutually agreed terms and conditions.

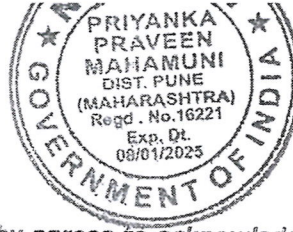
The terms and conditions of this Memorandum of Understanding are as follow:
